Subject: Regarding creating a committee to analyse and submit the report on Elephant Breaking System by Kerala wild life Organization.

Reference: 1. Request sent by Mr. Suresh, Erumapetti regarding amendment of the Elephant Breaking system to the Minister, Forest & Wildlife department, Kerala on 14.09.2009.  
2. Request sent by Mr. Mohan Kumar, Ajith Engineering works, regarding amendment of the Elephant Breaking system to the Minister Forest & Wildlife department, Kerala.

**Order No. DDC – 699/2019 on 10.07.2019**

Mr. Suresh and Mr. Mohan Kumar have requested the Kerala Wild life Organization, Forest department to amend the Elephant Breaking System with reference (1) Mr. Suresh has requested the Minister, Forest & Wildlife department, Kerala, to amend the Elephant Breaking System on 14.09.2009. (2) Mr. Mohan Kumar, Ajith Engineering works, has requested the Minister, Forest & Wildlife Department of Kerala, to amend the Elephant Breaking System. The Breaking System has been implemented to control musth Elephants. Before the amendment, I order, that a committee has to analyse the pros and cons of this system and submit a report. Both elephant and the handler's safety have to be analysed. The research committee should include the following personnel:

This Elephant Breaking system should be tested on at least ten Elephants before it is amended. The expenses related to this examination should be payable at Thrissur.

The place and time of the Breaking system examination should be decided by Mr. Suresh and Mohan Kumar along with the Kerala Elephants Owners Association. The Chief Forest Veterinary officer should submit all the related reports within one week post the examination.
