Implementation of PCA Act, 1960 and the Judgment in CRR no. 533 of 2013 passed by Hon'ble Punjab & Haryana High Court.

9/35 Dated Chandigarh the, 28th Dec,2019

All the Deputy Directors of AHD posted at District level are hereby directed to implement the PCA Act, 1960 and the Judgment passed by Hon'ble High Court in CRR no. 533 of 2013 titled as "Karnail Singh and others Vs. State of Haryana" in true letter and spirit.

It is further directed that wherever, you found someone using any spike stick or bit or found any animal with spiked or thorny bits please take immediate action such as; to replace that spike bit with the normal (Iron or plastic) bit, as per availability. It is directed that for this purpose you may buy from SPCA and keep with you normal (UNSPIKED) BITS at all times and take away from the animal owner the SPIKED BIT and give him a FREE UNSPIKED BIT then and there. Old SPIKED Bits be broken and kept in stock for disposal as scrap later. Furthermore in case the animal is found injured in that case provide, immediately all veterinary assistance as required to cure the ailment/ injury of such animal. If the situation is exaggerated or the animal owner resists or refuses to use UNSPIKED BIT in that case make compliant to the Police Deptt. in that area to launch prosecution against the owner or the wrong doer.

The Director General, Animal Husbandry is also hereby directed to provide grants from SPCA to all the DD's for the aforesaid propose and monitor all such cases, periodically, in the interest of livestock of the State as well as of the department.
