





PETA India to the Rescue

Besides helping police register FIRs in over 300 cruelty cases, PETA India staffers responded to more than 50,000 calls for emergency assistance, which included rescuing animals and, in many cases, providing them with veterinary care, vaccinations, sterilisation surgeries, and, often, ongoing care. We also neutered, vaccinated, and released more than 820 community cats in our ongoing cat sterilisation campaign in Mumbai.

After PETA India tipped off Delhi police, thousands of birds were rescued from illegal traders in Kabutar market. Following our complaints, officials in Lucknow rescued 11 rose-ringed parakeets from illegal traders and the Chengalpattu forest department seized seven illegally kept parakeets from fortune-tellers.

PETA India worked with police to stop plans for an illegal bullock cart race in Kadamvadi village. After receiving our complaint, Palakkad police registered an FIR and arrested six participants of an illegal bullock cart race. The AWBI advised the police in Andhra Pradesh to enforce the ban on cockfighting.

We worked with the Uttar Pradesh Forest Department to rescue a langur and with officials from the Vijayawada Forest Department to rescue a troop of monkeys. In both cases, the monkeys had been cruelly and illegally held for weeks simply for seeking food. After a medical examination, all the animals were released into nearby forested areas.

After learning that some residents of Veldanda mandal planned to bury a live bull as a sacrificial ritual, we worked with police to put an end to the ghastly killing.

In 2022, as always, PETA India didn't miss a single opportunity to help animals.

When war broke out between Russia and Ukraine, PETA India made an urgent plea to the minister for fisheries, animal husbandry, and dairying to relax rules regarding veterinary documentation for companion animals travelling from Ukraine to India. And a memorandum was issued shortly thereafter, thereby making it easier for Indians to flee the warzone with their beloved animals.

PETA India scientists shared our Research Modernisation Deal, a roadmap to ending animal experiments, with policymakers and continued successfully persuading researchers in universities and private and government institutions to replace various archaic, cruel animal tests with modern, humane methodology.

We campaigned to help animals raised and killed for food and clothing and those exploited for entertainment with attention-grabbing billboards and other advertisements, head-turning demonstrations, eye-opening investigations, and thoughtful, factual interactions with government and law-enforcement officials, corporations, and members of the public.

We held over 80 Compassionate Citizen workshops (virtual and in person) for nearly 2500 schoolchildren who learned about the importance of respect for animals and took kindness pledges. Over 1 lakh students also signed our petition to stop the use of elephants for entertainment. PETA India's youth division's virtual reality experiences, "I, Calf" and "I, Chicken", reached thousands of students who learned about the horrific suffering animals endure on dairy, egg, and chicken-flesh farms.

Our Twitter posts were seen close to 90 lakh times, and our Facebook and Instagram pages reached more than 500 lakh and 140 lakh people, respectively. Hundreds of thousands of visitors flocked to our websites to learn more about how to help animals and support our work.

This review highlights just some of our achievements in this past year – all made possible by your support, for which we are extremely grateful.

Groundbreaking Victories for Animals

After submitting evidence of legal violations and cruelty to animals, PETA India gained custody of more than 150 rats and mice from the Jawaharlal Institute of Postgraduate Medical Education & Research in Puducherry and secured their lifelong care at a sanctuary.

Our scientists helped redefine guidelines at the National Medical Commission, whose new guidelines for its postgraduate pharmacology curriculum call for the use of several non-animal teaching and training methods, no longer mandating certain routine experiments on animals.

A paper co-authored by PETA entity scientists and published in *Toxicology in Vitro* demonstrated replacing media containing foetal bovine serum with animal-free media, setting a precedent for the field of *in vitro* research.

Following our appeal, the governments of Andhra Pradesh, Chhattisgarh, Delhi, Goa, Gujarat, Himachal Pradesh, Karnataka, Madhya Pradesh, Meghalaya, Rajasthan, and Uttar Pradesh took action to prohibit the manufacture, sale, and use of gestation and farrowing crates.

Our investigation into Mumbai's Deonar slaughterhouse revealed that workers failed to stun buffaloes before slitting their throats and killed animals in full view of others, among other rampant abuse. And our undercover investigation into hatcheries across five major egg- and chicken meat-producing states exposed the illegal killing of thousands of sensitive chicks by live burial, drowning, crushing, and suffocation.

Our exposé of meat and wildlife markets in northeast India revealed animals kept in filthy conditions and dogs illegally sold for meat.

Numerous members of Parliament backed our appeal for the removal of the legal provision that allows animal sacrifice. Following our requests, the Animal Welfare Board of India (AWBI) urged authorities to stop the illegal treatment of animals in the lead-up to Eid al-Adha and the Punjab Bureau of Investigation urged police in that state to take action. Meanwhile, after hearing from PETA India, the office of the assistant inspector general of police in Chhattisgarh wrote to police superintendents urging them to stop the illegal transport and killing of animals during religious festivals for animal sacrifice.

We partnered with Metro Brands to launch its first-ever vegan shoe collection. Luxury fashion label JADE by Monica and Karishma joined our "PETA-Approved Vegan" programme. And after discussions with PETA India, designer footwear brand Empyrean Luxury stopped using leather.

We persuaded others that animals do not belong in circuses: BookMyShow removed animal circuses from its platform. After receiving our complaint, the AWBI called on authorities to take action against Ajanta Circus for using animals illegally. Pune city police filed a first information report (FIR) against Rambo Circus following our complaint that live fish were being swallowed then regurgitated, among other abuse.

More than 100 veterinarians supported our efforts to pass draft rules to prohibit the use of animals in circuses. In response to a public interest litigation filed by PETA India, the High Court of Delhi called on the central government to clarify its stance on prohibiting animals in circuses.

After hearing from PETA India, Fish Eye Network director Pooja Bhatt pledged not to use animals in the company's films and the AWBI issued an advisory to encourage replacing the use of live animals in films and television shows with modern technology.

After we submitted a petition, the Calcutta High Court ordered the formation of an inspection committee, including a PETA India representative, to report on unlicensed and unfit horses used to haul tourist carriages in Kolkata. PETA India and the CAPE Foundation wowed Kolkata media and the public with a Victorianstyle electric carriage that can replace horse-drawn carriages. And following our complaint to authorities on the rampant use of illegal spiked bits, we teamed up with police in Chandigarh, Delhi, and Maharashtra to display dozens of the seized devices – designed to cause pain to horses' sensitive mouths – to the public.

We released heart-breaking details of a Fauna Police investigation revealing that pit bulls, mastiffs, and other dogs are mangled and killed in secretly organised, illegal dogfights in Haryana, Maharashtra, Punjab, Rajasthan, Uttar Pradesh, and elsewhere.

Meghalaya banned the manufacture, sale, and use of glue traps, and governments in Sikkim and Tamil Nadu demanded

enforcement of the ban on these torture devices after we sent them appeals.

We secured the surrender of the final five bullocks used to haul ice in Mumbai and numerous horses used to haul heavy carts in Delhi by replacing the animals with motorised vehicles.



Informing, Liberating, Persuading

Actor **Sonakshi Sinha** appeared in our ad urging shoppers to scrap skins, and designer **Rina Dhaka** slammed leather, the most polluting material in fashion, in our new video.

We teamed up with Hollywood actor Alicia Silverstone to provide relatives of hospital patients with 1000 vegan meals. A study published in BMJ Nutrition, Prevention & Health suggests going vegan can lower the risk of severe COVID-19 infection.



Actor **Pamela Anderson** helped send our methane offset starter kits to members of Parliament for Earth Day.

Sir Paul McCartney and other celebrities, including Madhuri Dixit, Raveena Tandon, and Arjun Rampal, joined our efforts to get abused elephant Jeymalyatha (aka "Joymala") moved to a sanctuary. And renowned author Shobhaa De called on the Rajasthan government to replace cruel elephant rides with electric carriages.

Bollywood star Alia Bhatt was named PETA India's Person of the Year for promoting animal-friendly fashions and kindness to dogs and cats. *Bombay Begums* star Pooja Bhatt won our Hero to Animals Award. We presented a Compassionate Kid Award to Anya Kunder for helping community animals during the COVID-19 pandemic. Actors Milind Soman, Alia Bhatt, and Sunny Leone were among the winners of PETA India's Vegan Fashion Awards.

We seized every opportunity to push for progress:

- On World Day for Animals in Laboratories, a PETA India supporter was "force-fed chemicals" and "electrocuted" in a provocative protest.
- We barbecued a "dog" in Lucknow and a "human" in Chandigarh to compel passers-by to question their speciesism.
- On Mother's Day, a supporter wore a coat adorned with baby dolls' parts to remind consumers that animals killed for their skin loved their babies, too.
- PETA India's carrot mascot encouraged JITTHON Juhu 10K racers in Mumbai to "eat vegan for good health".
