Allabakash, Budekal, Adhoni town, Kurnool district (A2) were brought a camel from Hyderabad to Gooty town for slaughter purpose having without any permissions from the concerned department. On the information of Animal Husbandry Board member, the SI of police and Staff of Gooty Police Station rescued the camel from slaughter and taken possession of camel for safe custody and after explained grounds of arrest to the accused and arrested them under the cover of confession, arrest and seizure proceedings.
