Shafiq 2. Ms. Zubair and their associates of opposite to Osmania college. Kurnool for slaughtered on 02 Feb 2024 for selling their meat by violating of the Rajasthan Camel (Prohibition of Slaughter and Regulation of Temporary Migration or Export) Act, 2015. Section 5 of the said Act prohibits temporary migration or export of camel from the state of Rajasthan without permission of the competent authority. The Act also prohibits transport of camels outside Rajasthan when it is likely for the purpose of slaughter.
