Subject: Cruelty to a crab during your press conference in Pune

Dear Shri Pawar ji:

I am writing to you on behalf of People for the Ethical Treatment of Animals (PETA) India and our more than two million members and supporters to express our deep concern about your cruel treatment of a tied crab who was struggling and trying to escape as you suspended the animal by a string to make a point during a press conference in Pune on 2 April 2024. We have received numerous complaints about this incident, which is documented in this viral video (https://rb.gy/r8cn8o)

Research shows that crabs are intelligent individuals who can feel pain and suffer. They explore their surroundings, have good memories, and communicate with each other. By inflicting pain and suffering on this crab, you have violated Section 11(1)(a) of the Prevention of Cruelty to Animals Act, 1960; Article 51(A)(g) of the Constitution of India; the Maharashtra Model Code of Conduct; an order issued by the Office of the Chief Electoral Officer dated 24 March 2014 prohibiting the use of animals for election campaigning (Annexure 1); the Election Commission of India Manual on Model Code of Conduct; and a letter issued by the Election Commission of India on 19 September 2012 (Annexure 2).

Society looks to public figures like you to set an example of kindness and ethics. We hope you will use your position to advocate and legislate for stronger policies to protect animals and never harm another animal or use one for a political purpose again.

We urge you to give custody of the crab that you used for the press conference to PETA India so that we can provide the animal with veterinary care and rehabilitate back into nature. May we please know how we can collect the crab? I can be reached at 7303787382 or at ShauryaA@petaindia.org.
