नकल दरखास्त जैल है,"Dear Sir,I am writing to you from People for the Ethical Treatment of Animals (PETA) India to bring to your notice the incident of brutal killing of a dog by a group of individuals who attacked the animal with huge sticks in Ladwa, Kurukshetra, Haryana and to request you to register an FIR under the relevant provisions of law against the individuals in the video.It has been brought to our attention by a concerned local that on April 7th, in the village of Gangory, P.O Gajlana, Ladwa, a disturbing incident took place. A group of individuals viciously attacked a Boxer breed dog with large sticks. Subsequently, more individuals joined in. collectively subjecting the dog to repeated blows until it succumbed to its injuries and tragically passed away. The accused have been identified as Ankush s/o Aman kumar, Rohit s/o Sailinder, Vikram s/o Man Singh, Mohit s/o Dilip urf Puppy, Soham s/o Dilip urf Puppy, Hunny s/o Rajpal, Lucky s/o Gurcharan and Sunny urf Gabroo s/o Naresh urf Lilla. This incident occurred in presence of two other dogs. Once the dog died, the body was wrapped in a net and removed for disposal from the scene of crime by the accused, as depicted in video evidence. This merciless act resulted in the dog enduring a brutal and agonizing death as other villagers gathered around and stood as mute spectators to cruelty the dog was subjected to. The video regarding the said incident and of the animal is linked below and as well attached as Annexure 1 for your perusal.<https://www.dropbox.com/scl/fo/3k57xr3z9y6yppw08ddw3/AOeyLoUGbmB1rqa4gAyv4kA?rlkey7otzejqsuzo99nswc7wvbnvsttrwpcymydl0> The killing and maiming of any animal is a grave and serious offence under Section 429 of the Indian Penal Code, 1860 (IPC) which makes the act of killing, poisoning, maiming or rendering useless of any animal punishable with imprisonment for a term which may extend to five years, or with fine or both. Acts done in furtherance of common intention by several persons is an offence under Section 34 of the IPC. Moreover, it is evident that the deliberate disposal of the dog's body by the accused individuals was an attempt to obstruct justice. This act aimed to eliminate crucial evidence that could have been used to establish the commission of the offense. Such actions fall under Section 201 of IPC, which pertains to causing the disappearance of evidence of an offense or providing false information with the intent to shield the perpetrator from legal consequences.Section 11(1) of the Prevention of Cruelty to Animals (PCA) Act, 1960 defines acts that are considered cruel to animals and are punishable under the law. Section 11(1)(a) prohibits the beating, kicking, torturing or treating of any animal in a manner so as to subject to unnecessary pain and suffering. Section 11(1)(1) of the PCA Act further makes the act of mutilating any animal or killing any animal (including stray dogs) a cognisable punishable offence.We'd like also to bring to your attention
