organized by AfterAll events at Fujin in Itanagar.
Respected Officer-in-charge,

I am writing to you on behalf of People for the Ethical Treatment of Animals (PETA) India, the countrys best-known animal rightsorganization, to bring to your attention an extremely disturbing incident of a chickens head being ripped apart by an individual named Kon Wali Soncruelly using a sharp object and drinking the blood during a performancethat was organized by After All event at a restaurant called Fujin on 27thOctober in blatant violation of the Bharatiya Nyaya Sanhita (BNS), 2023 and Prevention of Cruelty to Animals (PCA) Act, 1960. An emailcomplaint regarding the same was submitted on the 28th of October 24.A video of this cruel act was shot by a concerned person in the audience, which has been attached as Annexure I for your perusal. During hisperformance, Kon Waii Son is seen bringing a live chicken on the stageonly to mercilessly pluck the head of the chicken and ferociously bite into the body of the chicken to drink the blood while the chicken is seenflapping the wings in pain after being beheaded. The venue and the eventcompany had posted about the event on their Instagram, and thescreenshots of the same have been attached as Annexure II and AnnexureIII, respectively. Section 325 of the BNS is reproduced below for ready reference:6:09 pm, Who ever commits mischief by killing, poisoning, maiming or renderinguseless any animal shall be punished with imprisonment of eitherdescription for a term which may extend to five years, or with fine, or withboth. The accused is also in violation of the PCA Act of 1960. Section 3 of the Prevention of Cruelty to Animals (PCA) Act, 1960 makes it the duty ofpersons having charge of animals to ensure that animals under theirownership or care are not subjected to unnecessary pain or suffering. Section 11(1) of the PCA Act, 1960 defines acts that will are considered tobe cruel to animals and make the same punishable under the law. Section11(1)(a) prohibits the beating, kicking, torturing or treating of any animalin a manner so as to subject to unnecessary pain and suffering. Section11(1)(1) of the Act further makes the act of mutilating any animal or killingany animal a cognizable and punishable offence. Thus, the acts of torturing, killing, or mutilating any animal is a cognizable offence under PCA Act. As you may know, The Prevention of Cruelty to Animals (SlaughterHouse) Rules, 2001, and The Food Safety and Standards (Licensing andRegistration of Food Businesses) Regulations, 2011, require that animalsbe slaughtered only in facilities registered with appropriate authorities. Prevention of Cruelty to Animals (Slaughter House) Rules, 2001, statesthat No person shall slaughter any animal within a municipal area exceptin a slaughterhouse recognized or licensed by the concerned authorityempowered under the law for the time being in force to do so. Open areas, pandals, temples, or any other structures/places are not recognized orlicensed slaughterhouses and do not have any facility for stunning animalsor individually killing them as mandated under these Rules. Violation ofthese rules framed under the PCA Act, 1960, is punishable under Section 38(3) of the PCA Act, 1960. Its the principal responsibility of the state police department to ensure thatall laws are upheld and enforced. Wed also like to call to your attentionthe Supreme Courts decision in the judgment issued on 7 May 2014 inSLP(C) No 11686 of 2007 that its the duty of the government to enforcethe PCA Act, 1960, and that if the provisions of the act and the directions and declarations of the court are not properly and effectively complied with, the government should see to it that disciplinary action is takenagainst erring officers so that the object and the purpose of the Act can beachieved passIn light of the above-mentioned facts and legal provisions, I request you to directions to register an FIR against the performer, organizers of theevent, and all other people involved in the barbaric killing of the chickenunder Sections 3(5) and 325 BNS and Sections 3, 11(1)(a), 11(1)(1) and 38(3) of the PCA Act, 1960 and any other relevant law(s).
